Initiation of Laguna Planning Process

The Board of Directors hereby requests that the City of Santa Rosa and the Subregional Wastewater Reclamation System participate in a Coordinated Resource Management and Planning (CRMP) process in the Laguna. This is a locally driven planning process that has worked successfully throughout California. The Foundation proposes to initiate and coordinate the CRMP, with joint participation and funding from the City and County.

We would like the opportunity to meet with city staff to discuss the process and our proposal in detail. We also strongly recommend that the Council send representatives to a two-day training workshop sponsored by the Napa County Resource Conservation District and the San Francisco Bay Regional Water Quality Control Board (information attached). The workshop covers planning topics of immediate concern to the City, and shows how the CRMP process can help resolve conflicts.


Upon receipt of your letter, several questions were presented by members of the City Council regarding the specifics of the joint participation that your organization has in mind.
